- MAKERS QUARTER | SAN DIEGO'S EMERGING NEIGHBORHOOD FOR TECH + INNOVATION
 As an innovation hub for a millennial workforce, this new emerging district completes one of the final chapters of growth for East Village's dynamic urban downtown neighborhood—ushering in new office, residential, restaurants, retail and entertainment space, alongside associated public parks and open space. The neighborhood is home to popular community venues such as SMARTS Farm and 10 Barrel Brewing Co., soon to be joined by the highly anticipated opening of Punch Bowl Social, and leaders of San Diego's innovation economy including Urban Discovery Academy and Fuse Integration. Later this year Makers Quarter will open doors to the neighborhood's residential anchors, Broadstone Makers Quarter (7-story, 265 units, architect: JWDA) alongside an additional Makers Quarter residential tower (33-story, 406 units with an office and retail component, architect: Carrier Johnson). Makers Quarter anticipates the completion of its six-city block build out by 2020-2025.
- BLOCK D | AIMING TO BE DOWNTOWN'S FIRST LEED PLATINUM, ZERO-NET ENERGY OFFICE BUILDING Later this month, BLOCK D will make its debut in Makers Quarter. As downtown San Diego's first multi-tenant commercial office property in nearly a decade, BLOCK D also aims to make headlines as downtown's first net-zero energy and LEED Platinum certified building (one of the most distinguished sustainability designations in the country). The 63,000 square-foot, six-story office hub with ground floor retail employs human-centered design and an environmentally conscious infrastructure to build a healthier workspace that improves productivity. Counted among BLOCK D tenants, BASIC Agency (a nationally renowned creative design agency whose clients include Nike, Beats by Dre, REI and Nixon) recently signed a lease on the building's expansive 5th floor layout, which will house the company's San Diego headquarters.
- LANE FIELD SOUTH | DOWNTOWN'S WATERFRONT TRANSFORMATION OF SAN DIEGO'S FORMER BASEBALL STADIUM
 This \$138.5 million, 400-room full-service Intercontinental-branded and managed hotel is located on the southern portion of Downtown's
 former waterfront baseball stadium fronting Pacific Highway with a two-acre public park on the western portion fronting North Harbor
 Drive and a new, landscaped pedestrian corridor to the south. Lane Field South is slated for completion in August of 2018.
